## REVISION IN LABOUR WELFARE FUND RATES IN TAMIL NADU

The Government of Tamil Nadu vide Notification G.O.MS. No. 161, revised the rate of LWF contribution under the Tamil Nadu Labour Welfare Fund Act, 1972. Please refer to the notification appended herewith and the table below for the revision:

## EXEMPTION UNDER THE HIMACHAL PRADESH SHOPS AND COMMERCIAL ESTABLISHMENT ACT, 1969

The Government of Himachal Pradesh vide Notification No. Shram (A)4-4/2017, exempted all Shops and Establishments from the following provisions under the Himachal Pradesh Shops and Commercial Establishment Act, 1969.:

- Section 8: Intervals for meals or rest
- Section 9: Opening and Closing hours and
- Section 10: Close day

The exemption is effective from 28th December 2022 till 2nd January 2023. Please refer to the notification appended herewith for more details.

## REGISTRATION AND LICENSING SERVICES THROUGH SINGLE WINDOW SILPASATHI PORTAL IN WEST BENGAL


In exercise of the powers conferred by Clause (b) of Sub-section (1) of Section-3 of the Minimum Wages Act, 1948 (Act 11 of 1948) read with Sub-Section (2) of Section 5 of the said Act and after considering the recommendation of the Committee appointed under Clause (a) of Sub-Section (1) of Section - 5 of the said Act, the Governor of Tripura is pleased to revise the basic minimum rates of wages of the employees/workers engaged in the employment of "Shops And Establishments" in Tripura. The rates of wages specified in column no. 3 of the schedule below shall be payable to the different categories of workers/employees engaged in the aforesaid employment in the State of Tripura as specified in the corresponding entries in column no. 2 of the schedule.

The revised minimum rates of wages shall come into effect from 01-10-2022.

5. 


